PERSONAL DATA THAT WE PROCESS

ESPACIO FLAMENCO ENCuentROS processes your personal data because you provide them yourself or because you use our services. Below you will find an overview of the personal data that we process:

- Dancer first and last name (es)
- Sex
- Date of birth
- Address data
- Phone number
- E-mail address
- Relevant information required when taking our dance classes
- Bank account number

SPECIAL AND / OR SENSITIVE PERSONAL DATA THAT WE PROCESS

Our website does not intend to collect data about website visitors under the age of 16. Unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us via info@espacioflamencoencuentros.com and we will delete this information.

FOR WHAT PURPOSE AND ON WHAT BASIS WE PROCESS PERSONAL DATA

ESPACIO FLAMENCO ENCUENTROS processes your personal data for the following purposes:

- Handling your payment
- Sending our newsletter
- To be able to call or e-mail you if this is necessary to be able to perform our services or if there are questions or announcements about the dance lessons of you and / or your child (ren)
- To inform you about changes to our services and products
- To provide services and / or products to you

The basis for the processing of your personal data is the performance of the agreement that we conclude with you if you purchase our services or products. If we intend to process your personal data for a reason that is not related to the performance of the agreement, then we will ask for your consent before we start this processing.

AUTOMATED DECISION-MAKING

ESPACIO FLAMENCO ENCUENTROS does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions made by computer programs or systems, without involving a person (for example, an ESPACIO FLAMENCO ENCUENTROS employee).

HOW LONG WE STORE PERSONAL DATA

ESPACIO FLAMENCO ENCUENTROS does not store your personal data longer than is strictly necessary to achieve the purposes for which your data are collected. We use the following retention periods for the following (categories) of personal data:

- Personal details / address / e-mail address / telephone number:
Up to three months after termination of membership.
Reason: To be able to reach you when handling the service
- Other personal data that you actively provide:
Up to three months after termination of membership
Reason: To give you the opportunity to store these data elsewhere
- Bank account number / name:
7 years
Reason: To comply with tax legislation

SHARING PERSONAL DATA WITH THIRD PARTIES

ESPACIO FLAMENCO ENCIENTROS only provides personal data to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

- BitNation is the supplier of StudioCloud, our membership administration software. All the aforementioned personal data are processed in StudioCloud. BitNation has access to this information to process and support our membership administration.

COOKIES, OR SIMILAR TECHNIQUES, THAT WE USE

ESPACIO FLAMENCO ENCIENTROS only uses technical and functional cookies. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remembers your preferred settings. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via your browser settings.

SEE, MODIFY OR REMOVE DATA

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by ESPACIO FLAMENCO ENCIENTROS and you have the right to data portability. This means that you can submit a request to us to send the personal data we have about you in a computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to info@espacioflamencoencuentros.com. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, within four weeks at the latest. ESPACIO FLAMENCO ENCIENTROS would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
